ANNUAL MEETING CONVENES at 6:30 PM

- 1. Meeting Minutes from Feb. 13, 2023 vote to approve (online at https://czresearch.com/halifax/MinutesHalifaxCommunityClub2023-02-13.pdf)
- 2. Treasurer's Report (John) The balance in the bank account at year end was \$22,300.95, an increase of \$2,300 over last year. Propane and electrical expenses increased about \$100 each over the last year, insurance was up \$30, and no major capital improvements were made, although the ice cream trailer received a new roof, a cabinet was purchased and assembled, and door hinges replaced. Thanks to Gary Rand, Jason Ashcroft, and David Jones. Income increased by \$1579 thanks to the new cafe. Senior Solutions changed the formula for reimbursement for the monthly senior meal. We netted \$537.39 compared to \$480 under the old formula. We also received the first matching donations totaling \$1048.55 from two donors who work for companies with those programs.

- c. Vote on Clerk (occurs annually) (incumbent is Laurel) The members elected Laurel.
- d. Add signature authority over the Community Club bank account at Brattleboro Savings & Loan (acct. #139001042) to Laurel Copeland – Voted in favor of.
- e. Sign letter to Benevity, workplace donation management Done.
- f. Ice Cream Wagon Gary Rand and Jason Ashcroft replaced the roof on the Ice Cream Wagon. Thank you, Jason and Gary!!!
- g. **MCC model update** Report on the Halifax Café (Laurel): In the first seven months of being open two days a week (10-1 on Thursday & Saturday), the Café welcomed at

least 122 people who made at least 544 visits. There were a few days when we did not keep track of who came in. We were closed four days between Thursday June 1 (opening day) and Saturday December 16, after which we closed for three weeks (5 Café days) for the holiday period. We hosted four speaker events including "Talk with the Fire Chief" and "Grid Reliability" which drew new people to the Café. We hosted two post-Café events (two beaver talks). We held fundraisers for Halifax Historical Society (4 days) and Halifax Cemeteries (1 day); our next fundraiser will be "Soup For Boots" for the Fire Department on Saturday January 27. All of the nuts, cookies, fresh fruit, snack bars, milk, cream, coffee, cocoa, tea bags, and baked goods have been donated. Several people also donated equipment (coffee thermos; teapot; coffee maker). The Select Board members have been exceptionally generous. David Jones, Gary Rand, and Pete Silverberg have repaired, replaced, and assembled things for us. Diana Conway has organized several events including connecting with the school to initiate "Read to the Dog" visits from Therapy Dog Kelso and his companion Linda Lyon. Andrea Underwood Jones and I have opened, provisioned (especially Andrea & David Jones), hosted, and closed up each day the Café was open. We are looking for a third person to spell us on occasion. In all, the Café brought in \$4,431; of that, we donated \$1,752 netting the HCC \$2,679 including \$1100 in checks shown in Treasurer's report under "donations." So far this calendar year the Café has hosted a COVID vaccination clinic on our first day open post-holiday (1/6/2024). That day, 20 people visited the Café including 8 who got COVID jabs (and one of those also got a flu shot).

Joan expressed gratitude for the expanded use of the Hall.

h. **Other new business** – All members are invited to propose maintenance / upgrade ideas for the Hall: kitchen flooring & padding, storm glass upgrade, solar panels / heat exchangers, other? It was suggested we look into getting the Hall in the registry of historic places, although this may limit what changes can be made to the building; pros and cons should be weighed carefully.
